☐ Yes, as the primary contact person, **I will contact all others from my organization attending the event** regarding the fair and will review the following rules with them.

☐ Yes, I understand that check in time begins at 7:00 AM and all vehicles must be out of the park by 9:00 AM. At conclusion of the fair, no vehicles may enter the park until 3:00 PM

☐ Yes, I agree to enter the park through the north entrance off 8<sup>th</sup> Street and will check in with the registrar before proceeding into the park.

☐ Yes, I understand that I will drive into the park and turn right. I will drive through the park in a counter-clockwise direction to select a canopy location. I will park on the right to unload my car (outer part of circle).

☐ Yes, I am aware that park benches are along the circle and I will not hit them. If I cause any damage to a park bench, I am liable for the cost of a repair or replacement.

☐ Yes, I understand that driving on the grass in the park is forbidden. There are sprinkler heads at the edge of the sidewalks that are easily damaged. I will be responsible for any damages to the grass or sprinkler heads if this rule is not followed.

☐ Yes, I understand that the canopy spaces in the park are on a first come, first served basis. No spot is reserved for my organization. Canopy spaces are marked by white chalk marks.

☐ Yes, I understand that the fair does not provide a canopy, table or chairs and I am responsible to bring my own.

☐ Yes, I will not drive stakes into the ground to hold down my canopy. Water filled milk jugs or other heavy items can be used to weigh down the canopy legs.

☐ Yes, I will exit the park as soon as my car is unloaded, I will exit the park via the north exit.

☐ Yes, I understand there will be no political parties, campaigning for a candidate or proselytizing for a religion permitted at this event.

☐ Yes, I understand exhibitors may have one car drive into the park to unload and sponsors may have two.
